Rules & Regulations of the Hostel

The following has to be compulsorily followed by students residing in the Hostel. Students are therefore, required to read carefully all the rules & regulations and conduct themselves accordingly.

1. Students shall respect the dignity of the Hostel Staff & treat them with due courtesy.
2. Room allotted cannot be changed without prior written approval of the Principal. No one other than allotted student shall stay in the room.
3. No visitor is allowed inside the room including parents.
4. Student shall be responsible for care of the room, furniture & fixtures, locks and keys and shall not disfigure the walls, roofs, doors or windows and any other structure etc. Any furniture /fixtures shall not be moved from its original place to another place. In case of damage to or loss of hostel property, the cost will be recovered from the student responsible for such damage or loss.
5. Appliances such as electric heater, induction, air cooler, electric iron, rice cooker, electric kettle, LPG stove and any other appliances are not allowed inside the room.
6. No form of cooking is allowed inside the hostel room.
7. No playing of colors or bursting of crackers is allowed inside the hostel room/ institute premises.
8. Eat food only in the designated mess room and no food is to be carried from Mess to the hostel room or anywhere outside. No Mess utensils are allowed to be carried outside the mess room.
9. Switch off fans, lights and air conditioners when out of room/not in use.
10. Water is an essential but scarce commodity and must be used judiciously.
11. No smoking and consumption of alcoholic drinks and / or narcotic drugs/any intoxicating substance nor enter the hostel premises in intoxicated state or possess any such materials.
12. No parties, birth day celebration of any sort is allowed inside the hostel room or Institute campus.
13. No group meeting/ gathering of any form is allowed in the hostel room/ hostel/institute premises.

14. No religious prayer/ worship/ meetings in any form shall be organized inside the room /hostel premises.
15. No outside orders of food /or any other parcel orders delivery will be allowed inside the hostel room.
16. Gate pass signed by Warden is required for movement outside the hostel/ institute. Return to hostel time for UG & PG students & MBBS Interns shall be as per timings notified from time to time. In case of stay outside, seek prior written permission. The Hostel administration will have no responsibility about the conduct of the student outside the hostel premises.
17. Student shall not stay outside/ loiter outside of the Hostel/ Institute premise beyond 8 p.m. for girls and 9 p.m for boys.
18. Student must register their movement in the Attendance System maintained in the hostel ground floor and also at Main Gate while they are entering into or going out of the hostel.
19. Report to the Warden in case of unacceptable behavior displayed.
20. No music or loud speaker system is to be played inside the room or kept.
21. Students are responsible for keeping their rooms, the common areas, corridors, bathrooms, stair case, and common room etc clean and tidy at all times. No littering in and around the hostel and any waste must to put into the wastebin.
22. No one shall enter inside others room/ hostel and create nuisances / disturbance / man handling / physical assault etc of any form.
23. No vehicle /Taxi is allowed inside the campus.
24. The hostel administration will not be responsible for any loss of personal belonging inside the campus/ hostel.
25. Ragging is a criminal offence & punishable and prohibited. Whosoever directly or indirectly commits, participates in, abets, or propagates ragging within or outside the hostel /institute campus will be punishable by law.
26. Public display of feelings and affection between male and female or within same gender will be considered as indecent act and not allowed in the vicinity of hostel/ institute campus.
27. Any form of indiscipline or violation by student shall be intimated to parents

28. Dress Code - The students should be decently dressed when they are out of rooms. They shall wear shoes that covers the feet when outside of the hostel room. No bathroom slippers/ *hawai chappals* are allowed outside of hostel room, in the institute campus and while on hospital duty.
29. Students shall vacate the hostel within the notice given by the Warden on completion of their /semester/session/ University Examination as the case may be.
30. Students must obtain 'No Dues Clearance Certificate' as applicable at least two days before vacating the hostel and hand over to the office of Controller of Examinations.
31. On vacating, hand over the complete charge of room inventory to the assigned person. Gates pass to be obtained from the Warden and handed over to the Security Guard on duty before leaving the hostel premises.
32. The definition of student for this purpose includes UG, PG and MBBS Intern. Since hostel is within the vicinity of institute campus, the scope of rules and regulations would automatically include hostel room, hostel premises, institute premises, hospital or any other place within the institute premises.
33. The list is indicative and not exhaustive and any act which is subversive of good discipline/ conduct shall be construed as violation of rules and regulations and therefore all instructions/notices displayed on hostel notice boards from time to time shall form part of rules and regulations and be deemed to have been read by all student and excuses for non-compliance of such instructions and notices will not be accepted.
34. **Violation of the above Rules & Regulations will attract strict Disciplinary Actions: suspension, detention, rustication, expulsion / fine or both as deemed fit decided by the Principal.**
